



Tax Time

The government isn't sending forms in the mail this year. Instead, forms are available at libraries, post offices, and on the internet. Come into the library to pick up, print out, or fill out your forms online!

The library has:

- Individual copies of federal and Illinois state tax forms
- Forms and guides available for photocopying
- Reference books: filed under R 336.2
- Access to the internet

To do your taxes online:

- You may reserve a computer up to 24 hours in advance
- Login for 90 minutes at a time, with an option to extend for another 60 minutes (if no one is waiting for a computer, we're happy to further extend your time)
- Printing costs 10 cents per side
- If you don't see the form you're looking for, we can help you search for it online
